

OHIO STATE COUNCIL OF EPSILON SIGMA ALPHA INTERNATIONAL

STANDING RULES

1. Order of business shall be followed as stated in the Ideals Manual. (1971-1972)
2. No board member or member of a chapter may publish hours or money donated in the Buckeye Jonquil prior to the judging for the annual philanthropic awards. (1978)
3. Late entries for any State Convention contest will not be judged or accepted. Exceptions will be made at the discretion of the Executive Board and/or the Awards Chairman. (Adopted 1959-60. Amended 1988, 2005).
4. The **First** Vice President/President shall be the automatic delegate to the ESA Headquarters State President's Leadership Seminar contingent on funds available. (1978)(2018)
5. In the event no bid is received for a specific council meeting, the Ohio State Council Executive Board shall appoint any Ohio Council Chapter to serve as hostess. (1979).
6. Registration fee for the Ohio State Council meetings shall not exceed \$35.00. Any increase in this amount necessary by a hostess chapter must be submitted in writing for approval by the Executive Board. (1987) (1991) (1995) (1999) (2008)
7. Registration fee for the Ohio State Convention shall not exceed \$80.00. Any increase in this amount necessary by a hostess chapter must be submitted in writing for approval by the Executive Board. (1987) (1991) (1995) (1999) (2008)
8. Ohio State Council annual dues shall be assessed only one time per each year per member. Individual records shall be kept by the State Treasurer. (2007)
9. Chapters shall pay annual dues for each member who affiliates during the fiscal year. (2007)
10. Individual members as defined in Article IV, Section 1-B and Members-At-Large shall pay annual dues upon affiliation. (2007)
11. Individual members as defined in Article IV, Section 1-B, new chapters and Members-At-Large affiliating after March 1, by payment of their annual Ohio State Council dues, shall have membership privileges for the remainder of that year and until the due date of the following year. (2007)
12. Ohio State Council annual dues include a copy of the Buckeye Jonquil. Hard copies will be mailed directly to those without e-mail access. (2003)
13. Each member chapter affiliating with the Ohio State Council shall pay annual dues for the current fiscal year. (2007)

14. Chapters will be assessed a \$10.00 "Late Fee" if the chapter dues are not paid after a 30 day grace period from the due date. (1979)
- 15. Dues for the coming year shall be voted on at the OSC Convention by the Chapters present. The amount decided on will be recorded in the Convention minutes. (2018)**
16. It shall be the privilege of only the hostess chapter and/or the Ohio State Council to offer items for sale at the Ohio State Council meetings and the Ohio State Convention. (1983)
17. All new awards or changes to awards to be presented at Ohio State Council meetings or convention must first be submitted to, and approved by the Executive Board . (1988)
- 18. There shall be a special Presidential transportation expense fund, if necessary. The Ohio State Council Ways and Means Chairman will be responsible for establishing a raffle to support this travel expense. Aforementioned raffle will be held at each state meeting and convention. Each chapter will be responsible once a year for a raffle item. (1992)(2018)**
19. At the discretion of the hostess chapter, a late fee of \$10.00 may be charged for registrations to council meetings and conventions received by the registration chairman after the deadline date. (1993)
20. Ohio State Council Outstanding Sisters and Outstanding Pledges shall each be honored with a certificate. (2007)
21. Gift for International Representative to the Ohio State Council Convention not to exceed \$25.00. (2001)
- 22. The Budget Line Item for Membership Chairman is to be used only for membership events sponsored by the Ohio State Council with the Membership Chairman responsible for said event. (2018)**
